SikaGrind® ES 2178 is a liquid, ready-to-use cement additive designed to enhance cement performance. In addition to acting as a Grinding Aid in the milling process and a flow aid in cement conveyance, SikaGrind® ES 2178 improves specific cement properties by the activity of its chemical components. These act in the modification of clinker characteristics and in the enhancement of its hydraulic properties.

Products of the SikaGrind® ES series are specifically designed to increase early strength of cement. These benefits can be used either for achieving superior product performance or for cement optimization while maintaining the original performance level.

APPLICATION INSTRUCTIONS

SikaGrind® ES 2178 can be metered onto the mill feeders or injected into the mill. The recommended dosage rate is between 300 - 600g per ton of cement. Other dosages may be required in specific situations. The optimum dosage should be evaluated in plant trials. For further information please consult Sika Technical Service Department.

Calibrated dosing equipment with an adjustable flow rate and appropriate dosage range is recommended to obtain the maximum performance of the product.
