The best results are obtained when the admixture is added after all the other components are already in the mixer and after the addition of at least 80% of the total water. The water content is adjusted to obtain the desired consistence or workability.	
Compatibility	SikaPaver®-798 is suitable for mixes containing all types of cement and supplementary cementitious materials such as Microsilica (Silica Fume), Fly Ash (PFA), GGBS (Ground Granulated Blast Furnace Slag) and the following Sika products: SikaPlast®, Sika® ViscoCrete®, Sikament®, SikaPump®, Sika® FerroGard®, SikaFume®, SikaFiber®, Sika® Aer, Sika® Stabilizer, SikaControl® We recommend to perform trial mixes to establish the required performance when combining SikaPaver®-798 with the above products or other admixtures.
