#### DESCRIPTION

Sikament<sup>®</sup> NNSs is a highly effective dual action liquid superplasticizer for the production of free flowing concrete or as a substantial water-reducing agent for promoting high early and ultimate strengths. Suitable for use in hot and tropical climatic conditions.

USES

Sikament<sup>®</sup> NNSs can be used as a superplasticizer for the production of free flowing concrete for:

- Slabs
- Foundations
- Walls
- Columns
- Piers
- Slender components with dense reinforcement
- Piles

It is also used as a water-reducing agent leading to high early strength concrete for:

- Pre-cast and pre-stressed concrete elements
- Bridges and cantilever structures

Concreting guidance	The standard rules of good concreting practice for production and placing must be observed when using Sikament <sup>®</sup> NNSs in concrete. Refer to relev- ant standards. Fresh concrete must be cured properly especially at high temperatures in order to prevent plastic and drying shrinkage. Use Sika <sup>®</sup> Antisol <sup>®</sup> products as a curing agent or apply wet hessian.
APPLICATION INFORM	ATION
Recommended dosage	0.8 - 2.4 % by weight of binder. Higher dosages by weight of binder can be used depending on the mix design, raw materials, climatic conditions and concrete requirements. Trial mixes must be performed to establish the exact dosage rate required.
Dispensing	Sikament <sup>®</sup> NNSs is added to the gauging water or simultaneously poured with it into the concrete mixer at the batching plant. Do not add Sikament <sup>®</sup> NNSs directly to the dry mix.

For optimum utilization of its high water reduction property we recommend thorough mixing at a minimal wet mixing time of 60 seconds. The addition of the remaining gauging water (to fine tune concrete consistency) may only be started after two-thirds of the wet mixing time to avoid sur-

# IMPORTANT CONSIDERATIONS

Before pouring suitability tests on the fresh concrete must be carried out.

Due to the extended workability take special care that formwork is properly installed and secured.

If frozen and/or if precipitation has occurred, it may only be used after thawing slowly at room temperature and intensive mixing.

When using Sikament<sup>®</sup> NNSs a suitable concrete mix must be designed for the local material sources and should be trialed.

When accidental overdosing occurs the set retarding effect and workability increases. Additional air may also be entrained.

During this period the concrete must be kept moist in order to prevent premature drying out.
