Sikament[®]-600 N is a highly effective dual action liquid superplasticiser that imparts excellent slump retention for prolonged periods.

It is used for the production of free flowing concrete or as a substantial water-reducing agent for promoting high early strengths.

Suitable for use in hot and tropical climatic conditions.

USES

Sikament[®]-600 N can be used as a superplasticizer for the production of free flowing concrete for:

- Slabs and foundations
- Walls, columns and piers
- Piles

Stuctures with densely packed reinforcement

It is also used as a water-reducing agent leading to high early strength concrete such as:

- Pre-cast concrete elements
- Pre-stressed concrete
- Bridges and cantilever structures

Recommended Dosage	0.6 - 1.6 % by weight of binder Higher dosages up to 2.0 % by weight of binder can be used depending on

Compatibility	Sikament®-600 N may be combined with all types of Portland cement, con- cretes containing pozzolanic materials such as; GGBS, PFA , micro-silica and the following Sika products: SikaPump® Sika® FerroGard®-901 SikaFume® SikaFiber® SikaFiber® Sika Aer® Sika Aer® Sika® Stabilizer Sika®-1 WT We recommend to perform trial mixes to establish the required perform- ance when combined with the above products. Dispensing	Sikament®-600 N is added to the gauging water or simultaneously poured with it into the concrete mixer at the batching plant. Do not add Sikament®-600 N directly to the dry mix. For optimum utilization we recommend thorough mixing at a minimum wet mixing time of 60 seconds. The addition of the remaining gauging water (to fine tune concrete consist- ency) may only be started after two-thirds of the wet mixing time to avoid surplus water in the concrete.

IMPORTANT CONSIDERATIONS

Before pouring suitability tests on the fresh concrete must be carried out.

Due to the extended workability take special care that formwork is properly installed and secured.

When accidental overdosing occurs the set retarding effect and workability increases. Additional air may also be entrained.

During this period the concrete must be kept moist in order to prevent premature drying out.
