# HIGH RANGE WATER REDUCING ADMIXTURE FOR PRECAST CONCRETE

## DESCRIPTION

SikaPlast<sup>®</sup>-150 is a polycarboxylate based superplasticizer particularly formulated for the production of precast concrete elements, targeting its special demands regarding slump retention, very low water/binder ratios, use of double or triple blend mixes (cement, GGBFS, PFA and/or microsilica) and a high degree of compaction.

Suitable for use in hot and tropical climatic conditions.

## USES

SikaPlast<sup>®</sup>-150 can be used for:

- Precast concrete structures in general
- Precast concrete tunnel segments
- Pre-stressed concrete elements
- Post-tensioned concrete bridge segments
- Fiber Reinforced Concrete (FRC) containing steel, synthetic and or polypropylene fibers
- Low w/b ratio concrete requiring high workability, slump retention and high early strength development

# **CHARACTERISTICS / ADVANTAGES**

SikaPlast<sup>®</sup>-150 acts by surface absorption on the cement particles producing steric hindrance as well as electrostatic repulsion between the binder particles resulting in:

- Easier control during casting due to sufficient retention period and high early strength development
- High water reduction (leading to high density and strength) even in double or triple blend mixes (e.g. cement, GGBS, and silica fume)
- Low w/b ratio leads to very low water permeability, and chloride migration
- High early strength and strength development even with the use of low cement content mixes
- Improved shrinkage and creep behavior
- Excellent flow ability resulting in minimal placing and compacting efforts
- Does not contain chlorides or other steel corrosion promoting ingredients so may be used for reinforced and pre-stressed concrete construction

Recommended Dosage	0.5 - 3.5 % by weight of binder Higher dosages by weight of binder can be used depending on the mix design, raw materials, climatic conditions and concrete requirements. Trial mixes must be performed to establish the exact dosage rate required.
Compatibility	SikaPlast <sup>®</sup> -150 may be combined with all types of Portland cement (OPC and SRC), concretes containing pozzolanic materials such as; GGBS, PFA, micro-silica and the following Sika products: SikaPump <sup>®</sup> , Sika <sup>®</sup> FerroGard <sup>®</sup> -901, SikaFume <sup>®</sup> , SikaFiber <sup>®</sup> , Sika Aer <sup>®</sup> , Sika <sup>®</sup> Stabilizer, Sika <sup>®</sup> -1 WT, Sika <sup>®</sup> WT-10 We recommend to perform trial mixes to establish the required perform- ance when combining SikaPlast <sup>®</sup> -150 with the above products or other ad- mixtures. Please consult our Sika Technical Department.
Dispensing	SikaPlast®-150 is added to the gauging water or simultaneously poured with it into the concrete mixer at the batching plant. Do not add SikaPlast®-150 directly to the dry mix. For optimum utilization of its high water reduction property we recom- mend thorough mixing at a minimal wet mixing time of 60 seconds.The ad- dition of the remaining gauging water (to fine tune concrete consistency) may only be started after two-thirds of the wet mixing time to avoid sur- plus water in the concrete.

## **IMPORTANT CONSIDERATIONS**

When using SikaPlast<sup>®</sup>-150 a mix design must be selected for the local material sources used and trial mixes performed to verify suitability.

If frozen and/or if precipitation has occurred, it may only be used after thawing slowly at room temperature and intensive mixing.

SikaPlast<sup>®</sup>-150 should not be added to dry cement. Before pouring, suitability tests on the fresh concrete must be carried out. Due to the extended workability take special care that formwork is properly installed and secured. In case the setting time of concrete is extended, if cured properly, other properties may not be affected and higher ultimate strength is visualized. SikaPlast<sup>®</sup> products are not compatible with admixtures based on sulfonated naphthalene or melamine.
