DESCRIPTION

SikaControl®-1200 WT crystalline waterproofing liquid admixture is an integral crystalline capillary waterproofing admixture for concrete. It is designed for use in above- and below-grade applications.

SikaControl®-1200 WT consists of various active, proprietary chemicals. These active chemicals react with the moisture in fresh concrete with the by-products of cement hydration to cause a reaction, which generates an insoluble crystalline deposit throughout the pores and capillary tracts of the concrete. These crystalline hydration products are deposited and fill the pores and hairline cracks, effectively reduce the permeability of concrete, its capillary absorption and penetration of water and other liquids into the concrete. The concrete with SikaControl®-1200 WT reduces wa-

ter permeability of concrete structures and improves self-healing property in presence of moisture.

Suitable to use in hot and tropical climatic conditions.

USES

SikaControl®-1200 WT can be used in all structural concrete that is constantly or intermittently in contact with water such as sea walls, tunnels, basements, structural and pre-cast concrete. SikaControl®-1200 WT can also be used as crystalline waterproofing admixture for cement mortars and plasters.

SikaControl®-1200 WT can be used to enhance the waterproofing properties of structures such as:

- Building basement and foundations
- Sewage and water treatment plants
- Dams, canals, tunnels, harbours
- Tunnel and subway systems

TECHNICAL INFORMATION

Concreting guidance	Points to remember when producing concrete with enhanced waterproofing properties: • Ensure water / cement ratio is less than 0.5
	 Addition of superplasticiser from the Sikament®, SikaPlast® or Sika® ViscoCrete® range is advised to achieve minimum water/cement ratio. Good concrete practice as per ACI standards regarding mixing, placing and curing. Use Sika® Antisol® products as a curing agent or apply wet hessian.
Effect on setting	SikaControl®-1200 WT admixture has minor to no effect on concrete setting time within the recommended dosage range. However, it is recommended to test this in case any additives or blended cementitious combinations are used.

APPLICATION INFORMATION

Recommended dosage	1–2.5 % by weight of binder. Dosage depends on the mix design, raw materials, climatic conditions and concrete requirements. To ready mix concrete, a typical dosage of 6-7 kg per cubic meter of concrete is recommended. However, the optimum dosage to meet project requirements must be determined through trial mixes.
Dispensing	SikaControl®-1200 WT admixture is batched at the concrete production plant in a manner similar to admixtures. It may be batched in either a central or truck mixer. Follow the procedures outlined in ASTM C94 / C94M, Standard Specification for Ready-Mixed Concrete, for general batching and mixing instructions for concrete if adding to a truck mixer. Provide at least 5 minutes of mixing after the addition of SikaControl®-1200 WT admixture to ensure through and uniform distribution of the admixture in the concrete mixture.
Compatibility	SikaControl®-1200 WT is suitable for mixes containing all types of cement and supplementary cementitious materials such as Microsilica (Silica Fume), Fly Ash (PFA), GGBS (ground granulated blast furnace slag) and the following Sika products: SikaPlast®, Sika® ViscoCrete®, Sikament®, Plastiment®, SikaPump®, Sika® FerroGard®, SikaFume®, SikaFiber®, Sika® Aer, Sika® Stabilizer, SikaControl® We recommend to perform trial mixes to establish the required performance when combining SikaControl®-1200 WT with the above products or other admixtures. In all concrete application, SikaControl®-1200 WT will conform to the most stringent or minimum chloride ion limits currently suggested by construction industry standards and practices.
- SikaControl®-1200 WT has minor or no effect on workability of concrete. Prior site trials are advised to assess the effect and any increase or decrease in the workability can be adjusted by adjusting the admixture dosage or amount of water in use.
- It is strongly recommended that concrete should be properly cured particularly in hot, windy and dry climates.
