SikaFiber®-12 AE is a high quality, 100% virgin, polypropylene fibre designed to reduce the occurrence of plastic shrinkage and plastic settlement cracking whilst enhancing the surface properties and durability of a cementitious matrix.

SikaFiber®-12 AE is coated with a surfactant to improve initial dispersion and bond with the cement paste.

Suitable for use in hot and tropical climatic conditions.

SikaFiber®-12 AE is used to prevent micro-cracking due to plastic and drying shrinkage in cementitious systems such as:

- Concrete
- Shotcrete
- Cementitious overlays
- Industrial floor slabs
- Patch repairs to pre-cast elements
- Water retaining structures
- High performance concrete
- Precast concrete tunnel segments

Dispensing	Plant mixing: SikaFiber®-12 AE should be added to the mixer after all other ingredients and water. Use a mixing time that ensures uniform dispersion of the fibre. Truck mixing:
	SikaFiber®-12 AE is best added in the batching plant mixer; although in cases where this may not be possible addition in the truck can be done. The fibre should be added first with ~30 % of the mixing water. Add the other ingredients, the remaining mixing water and continue mixing for a further few minutes at full speed to ensure uniform dispersion of the fibre
