DESCRIPTION

Sika® Plastiment® PZ 328 is a high performance plasticising retarder, beneficial in maintaining workability especially in high ambient temperatures. Suitable for use in hot and tropical climatic conditions.

USES

- Ready mix concrete where workability retention coupled with retardation of initial set are beneficial
- To improve cohesion, workability and compactability in concretes using poorly graded/shaped fine aggregates
- Hot weather concreting where controlled delay to initial set is of prime importance
- Large slabs or bridge decks, etc. where the extension of vibration is needed to avoid cold joints
- As a synergy admixture in combination with Sika superplasticizer
- Ideal for site batches, precast and ready mixed concrete

FEATURES

- Considerably improves the cohesion of concrete, reducing segregation and bleeding
- Suitable for concrete where fine aggregates of poorly graded particle are part of the mix
- Reduces concrete placing challenges in hot weather by improved workability and workability retention in conjunction with extended setting times
- Reduces honeycombs and cold joint
- Improves pumpability of concrete

TECHNICAL INFORMATION

Concreting guidance	The standard rules of good concreting practice for production and placing must be observed when using Sika® Plastiment® PZ 328 in concrete. Refer to relevant standards. Fresh concrete must be cured properly especially at high temperatures in order to prevent plastic and drying shrinkage. Use Sika® Antisol® products as a curing agent or apply wet hessian.

APPLICATION INFORMATION

Recommended dosage	As a general guide, a dosage range of 200 ml to 850 ml per 100 kg of total binder is recommended. Depending on the desired properties, a dosage of up to 1000 ml per 100 kg of total binder shall be used. Trials should be carried out to determine the optimum dosage of Sika® Plastiment® PZ 328.
Compatibility	Sika® Plastiment® PZ 328 is suitable for mixes containing all types of cement and supplementary cementitious materials such as: Microsilica (Silica Fume), Fly Ash (PFA), GGBS (Ground Granulated Blast Furnace Slag) and the following Sika products: Sika®Viscocrete® SikaPlast® SikaPlast® SikaPlast® SikaPump® SikaPump® SikaFerroGard®, SikaFiber® SikaFiber® SikaStabilizer SikaControl® We recommend for trial mixes to be performed to establish the required performance when combining Sika® Plastiment® PZ 328 with the above products or other admixtures. Please consult our Sika Technical Department for further assistance.
Dispensing	Sika® Plastiment® PZ 328 should be added to the concrete mix during the mixing cycle at the same time as the water or the aggregate. Never add Sika® Plastiment® PZ 328 to the dry cement. No extension to normal mixing times is necessary.

IMPORTANT CONSIDERATIONS

- Sika® Plastiment® PZ 328 should not be premixed with other admixtures. If other admixtures are to be used in concrete containing Sika® Plastiment® PZ 328, they must be dispensed separately.
- When using Sika® Plastiment® PZ 328 a suitable concrete mix must be designed for the local material sources and trial mixes performed to verify suitability.
- With high workability mixes take special care that all formwork is properly installed and secured.
- When accidental overdosing occurs the set retarding effect and workability increases. Additional air may also be entrained. During this period the concrete must be kept moist in order to prevent prema-

ture drying out. If properly cured, the ultimate strength of the concrete will not be adversely affected.
