BASIS OF PRODUCT DATA

All technical data stated in this Data Sheet are based on laboratory tests. Actual measured data may vary due to circumstances beyond our control.

IMPORTANT CONSIDERATIONS

- Factors affecting air contents, include: type, grading and proportion of sand, and aggregates, cement content per m³, type and fineness of cement, water/cement ratio and temperature. In certain cases therefore, it may be necessary to increase the dosage above 0.15%.
- Air meter tests should be taken regularly and adjustments made to the dosage rate in order to completely control the amount of air entrainment, which should be in the range of 3–6 %.
- When accidental overdosing occurs (within reason), the set retarding effect increases. During this period the concrete must be kept moist in order to prevent premature drying out. There will also be an additional amount of air entertainment. For higher air entrainment requirement use SikaControl®-115 AER.
