- Proper block manufacturing methods, proper masonry mortar proportioning and mixing and proper use of SikaPaver[®] WP 240 AE admixture must be followed. Raked joints should not be permitted for water-repellent admixture system masonry projects. Remove excess mortar promptly and clean any residue.

APPLICATION INSTRUCTIONS

SUBSTRATE PREPARATION

The surface to be treated should be free of dust, oil, efflorescence and existing paint coatings. Cracks in concrete of more than 200 μ m must be repaired prior to application of the hydrophobic treatment. Cleaning is best achieved by brushing with suitable detergents or by light blast cleaning or steam cleaning etc. Best results are obtained on dry, very absorbent substrates. The substrate must look dry with no damp patches.

MIXING

SikaPaver[®] WP 240 AE is supplied ready for use and should not be thinned.

APPLICATION

SikaPaver[®] WP 240 AE is applied by using low pressure spray, brush or roller, working from bottom up, taking care not to let the product run. On horizontal application, avoid ponding on the surface. Test a small area of the concrete surface before starting general application to assure desired results and coverage rates.

CLEANING OF EQUIPMENT

Clean all tools and application equipment with water immediately after use.
