#### DESCRIPTION

Sika<sup>®</sup> Dilatec<sup>®</sup> BR-500 is a flexible waterproofing tape based on polyvinyl chloride (PVC) with advanced adhesion properties. The tape connects and terminates bituminous waterproofing membranes to Sikaplan<sup>®</sup> WP (PVC) sheet membranes. The B-edge on one side is bonded to the bituminous membranes with hot-melt bitumen. The R-edge on the other side is hot air welded to the Sikaplan<sup>®</sup> WP membranes. Thickness 1,6 mm. It is part of the Sika<sup>®</sup> Dilatec<sup>®</sup> joint sealing system.

Suitable for use in hot and tropical climatic conditions.
